



Editorial

Dear Shareholder,

Air France-KLM posted the best second quarter in our history with an operating result of €733 million. Our operating result improved again driven by an increase in our unit revenues (+5.4%) comi. The unit cost decreased, where higher inflationary cost were compensated by a lower fuel price. Net income of the Air France-KLM Group stood in the second quarter at €604 million, which was €280 million better than last year, restoring further our equity situation.

Besides the good financial results, we have seen that almost 25 million passengers were served in the second quarter (up 8.2% compared with the second quarter of 2022). Over the same period, the Group posted a +12.3% increase in unit passenger revenue per available seat kilometer (ASK) compared with the second quarter of 2022, driven by the increase in the load factor – particularly on the long-haul network – and by the improvement in yield.

As we continue to implement the Group's strategic roadmap, we have recently entered into ambitious partnerships in the field of sustainable development, paving the way for the Group's future in the medium and long term.
