

## AIR FRANCE KLM REDUCTION IN FUEL SURCHARGES

---

The oil price having remained below \$60/bbl for 30 consecutive days, Air France and KLM, as promised, are withdrawing the most recent fuel surcharge increases, i.e.:

- Seven euros on long-haul flights for Air France
- One euro on medium-haul flights and five euros on long-haul flights for KLM

These decreases are valid on tickets issued in France and Netherlands as of February 3, 2007.

As a result, the fuel surcharges are now as follows:

- Air France: eight euros on domestic flights, 12 euros on medium-haul flights and 44 euros on long-haul flights.
- KLM: 21 euros on medium-haul flights and 50 euros on long-haul flights.
