Editorial



Dear Shareholder,

On the 30th of April, Air France-KLM presented its first quarter results.

During this quarter the passenger demand was aligned with capacity growth resulting in 4% more passengers than last year with yield up 3%, thanks to long haul and premium segment performance. Not only the passenger business showed a positive unit revenue development, also the Cargo business performed very well with unit revenues up 16% and third-party maintenance revenue went up by 11%. Total group unit revenue increased 3.0% while unit cost went up by 2.1% and together with the significant fuel price decrease, the operating result improved by €161 million and stood at -€328 million this quarter.

For the full year 2025 we maintained our outlook, despite political and economic uncertainties, with growth in group capacity of 4 to 5%, an increase of our unit cost by a low single digit, net capital expenditures expected is between \in 3.2bn and \in 3.4bn and a leverage ratio (Net Debt / EBITDA) between 1.5x and 2.0x.

Air France-KLM partners with Amadeus to accelerate modern airline retailing transformation


